

## **Website Privacy Policy**

The Eurachem website is one of the principal dissemination mechanisms used by Eurachem. It provides information on the structure and purpose of Eurachem, forthcoming and past events, and access to Eurachem's Guides and other resources. The website holds some personal information about Eurachem officers and members, and may collect limited information about users of the website, either directly or in the form of 'cookies'. This policy explains how we use such information.

### **Use of contact information**

The Eurachem website holds contact information about Eurachem Officers, National Representatives, Liaison members and other useful contacts so that other members, or members of the public, can contact the relevant individuals for purposes relevant to Eurachem activities. This contact information always includes their name, role within Eurachem and email address. The website will also, if provided to Eurachem, hold a mailing address, telephone number, organisational affiliation and other details including, for example, job title and any academic or professional designation.

Eurachem does not display email addresses on its website unless specifically requested to do so. Individuals may be contacted via a website contact form which is made available on the website. Other personal information listed above will normally be included as part of publicly available contact information listed on the site contact form.

Eurachem will remove specific personal information from the website if requested to do so. Members should contact the webmaster or the Secretariat if they wish specific information about them to be removed.

Other than publication of contact information provided by members as above to further the aims of Eurachem, Eurachem will not disclose contact or other personal information to any third party.

### **Information for other purposes**

Eurachem may request information from members and other website users in order to provide specific information, such as website updates or news, or administer particular functions such as surveys. Such information will only be used for the purpose for which it is collected and will not be passed to any third party.

### **Cookies**

The Eurachem website uses 'cookies' – small items of information stored by a user's web browser – to enable particular site features, including management of registered user log-ins. Eurachem may also use cookies to compile aggregate data about site traffic and site interactions in order to offer better site experiences and tools in the future.

Users can, where their browser permits, choose to disable cookie use or (for some browsers) receive warnings when cookies are set. If users disable cookies, some site features will be disabled; specifically, pages requiring member login may not remain available or may require login on every access to the page.

The Eurachem website also uses cookies to serve third-party services that track aggregate information on our behalf, including services such as Google Analytics and AddThis, which can make further use of personal information. See the section on ‘Cookies set by other service providers’ for more information.

### **Google Analytics (Google Inc.)**
